Youth Entrepreneur Booth Guidelines

- All youth booth products must be pre-approved by WSE.
- At least 75% of product to be sold must be produced by the youth vendor.
- The youth vendor will use only compostable take-out ware (cups, silverware, etc.).
- All paperwork required to register youth booths must be completed and registered with WSE by youth vendor.
- The youth vendor is responsible for setting up the booth, merchandising and signage (with minimal adult assistance).
- Seasonal spaces are not available at youth booth rates.
- Youth booth spaces are 6x6 or less; larger spaces may be rented at the standard farmers market booth rate.
- Youth booths may team up and share a larger space to use a canopy
